SUMMARY ANNUAL REPORT FOR GREATER KANSAS CITY LABORERS WELFARE FUND

This is a summary of the annual report of the GREATER KANSAS CITY LABORERS WELFARE FUND, a health, dental, vision, temporary disability and death benefits plan (Employer Identification Number 43-6039074, Plan Number 501), for the plan year 11/01/2017 through 10/31/2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Greater Kansas City Laborers Welfare Fund has committed itself to pay certain medical, prescription drug, dental, vision, accident and sickness, accidental death and dismemberment and death benefits claims incurred under the terms of the plan.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$26,513,905 as of the end of plan year, compared to \$26,710,523 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$196,618. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$14,151,709 including employer contributions of \$12,440,613, employee contributions of \$1,505,707, gains/(losses) of -\$81,275 from the sale of assets, and earnings from investments of \$279,783. Plan expenses were \$14,348,327. These expenses included \$1,382,572 in administrative expenses, \$12,965,755 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
